Provide evidencebased responses for victim-survivors of domestic and family violence by creating pathways to safety through collaborative partnerships

safe steps is the only 24/7, family violence response centre in Victoria, providing a "state-wide entry point" for victim-survivors of domestic and family violence.

Services include information and referral, crisis response, specialist family violence risk assessment, safety planning, and access to supported crisis accommodation. We also provide specialist counselling nationally, through 1800RESPECT.

Our practice is trauma-informed and guided by evidence. We provide services to all victim-survivors and recognise that most of our work is dedicated to the needs of women and children which reflects the gendered nature of domestic and family violence.

Our research and advocacy is informed by our practice and promotes the voices and diverse experiences of victim-survivors. We value diversity and inclusivity and are committed to an intersectional approach. We advocate to create systemic change and effective pathways for victim survivors from crisis to safety and recovery.
